

Project Description: The proposed 2003 Long Range Development Plan for the UC Davis campus projects population and space needs out to the year 2015-16. The LRDP projects a campus population of 51,645 by 2015-16 (including students, faculty, staff, research park employees etc.), and projects 2.5 million additional gross square feet of academic and administrative space to be added to the 4.5 million existing gross square feet. The 2003 LRDP proposes new housing for 2,000 students on the Central campus in addition to existing housing plus a new university neighborhood and a research park. In addition to academic and administrative space, the LRDP proposes a multi-use stadium, relocation of the campus dairy, and relocation of various support service facilities out of the core campus.

This is to advise that the University of California (Lead Agency Responsible Agency) has approved the above-described project on November 20, 2003, and has made the following determinations regarding the above-described project:
